## Pro Shops Choose Their Rebate Amount Based on Product Display:

5% REBATE - REWARDS PLUS BASIC - pro shops receive a 5% rebate on Brunswick, DV8, and Radical balls. Participating pro shops are not required to display Brunswick, DV8, and/or Radical bowling balls.

10% REBATE - REWARDS PLUS PROFIT BOOST - pro shops receive a 10% rebate on Brunswick, DV8, and Radical balls and earn double rewards on applicable ball programs throughout the year. Participating pro shops MUST display Brunswick, DV8, and/or Radical bowling balls.\*\*

#### **PROGRAM DETAILS**

- Please allow 2-4 weeks for receiving initial shipment of balls.
- \*\*PROFIT BOOST pro shops must agree to prominently display Brunswick, DV8, and/or Radical bowling balls in their showrooms. This does not require exclusive display of Brunswick, DV8, and/or Radical bowling balls.
- Eligible purchases include all Brunswick, DV8, and Radical branded bowling balls purchased through a Certified Brunswick Consumer Products Distributor in the United States.
- Pro shops earn bi-annual rebates on Brunswick, DV8, and Radical bowling ball purchases of \$1,000 or more.
- · Pro shops will receive a rebate "check" redeemable through any Certified Brunswick Consumer Products Distributor located within the United States. Rebate "checks" will be sent directly to pro shops from Brunswick 4-6 weeks following the end of each rebate cycle.

- Pro shops will receive an email notification from Brunswick reporting ball purchases and applicable rebates 4-6 weeks following the end of each rebate cycle.
